P. 1714(a), Lead Plaintiff Rajesh Patel ("Lead Plaintiff"), on behalf of himself and all other members of the Settlement Class, hereby moves for entry of the proposed Order and Final Judgment, which will: (i) grant final approval to the proposed settlement of the above-captioned class action, as set forth in the Stipulation and Agreement of Settlement, dated January 18, 2024 (the "Stipulation");¹ and (ii) approve the proposed plan of allocation for distributing the proceeds of the Settlement to eligible claimants.

2. Lead Plaintiff will also move, pursuant to Pa. R. Civ. P. 1702, 1708, and 1709, for final certification of the Settlement Class.
